Subject: Subsidized Child Care Assistance Program's NC FAST Data Availability in CSDW

After much anticipation, the Subsidized Child Care Assistance NC FAST data universe will be available in Client Services Data Warehouse (CSDW) Monday, April 2, 2018. We believe that CSDW will provide counties with Subsidized Child Care Assistance information and data advancements that will assist counties to extend data gathering and reporting well beyond the classic search queries available with information from SCCRS.

The Subsidized Child Care Assistance NC FAST data universe applications will:

- Afford counties the ability to move seamlessly across applications to retrieve Subsidized Child Care Assistance Data and Knowledge from both the state legacy, Subsidized Reimbursement System (SSRS) and NC FAST data
- Include the Meta Data link to ensure county personnel, clients, and other supporting partnerships and agencies have immediate access to the data descriptions
- Provide the following standard ad-hoc queries/reports:
  1. Number of Children by Star Level
  2. Waitlist Reports
  3. GHB-139 Child Reimbursement Summary Report
  4. Fund Source Summary Report
  5. Children Turning 6
  6. Children turning 13
  7. Number of Children by Zip Code
  8. Children Served by Level of Care
  9. Children Served by Age and Star Level
  10. Children Served by Eligibility Category
  11. 4-Year-Old Children by Facility


