# **Work First Program**

**SUBJECT:** Work First Cash Assistance Sanctions

**EFFECTIVE DATE:** April 14, 2020

#### I. GENERAL INFORMATION

The Division of Social Services will temporarily suspend Work First cash assistance sanctions related to non-cooperation with child support and/or failure to perform work requirements beginning with the benefit month of March 2020 in response to the COVID-19 public health emergency declaration issued by the Secretary of Health and Human Services.

#### II. POLICY PROCEDURES

Applicants and recipients with active Work First sanctions for failure to cooperate with child support and/or failure to meet the work requirements are eligible to receive Work First Cash Assistance if all other eligibility requirements are met.

Effective immediately, Work First (WF) cash assistance eligibility for applications, changes or recertifications should be determined without consideration to existing Work First cash assistance sanctions.

- Active WF cash sanctions for existing cases for these specific reasons must be suspended in the North Carolina Families Accessing Services through Technology (NC FAST) system. The specific NC FAST sanctions related to child support and/or failure to meet work requirements are listed in the attached document: Work First Sanctions Related to Child Support or Work First Work Requirements
- For assistance ending sanctions refer to NC FAST Help job aid: Editing or End Dating Sanctions.
- The eligibility rules for new applications in NC FAST for Cash Assistance does not capture existing sanctions for individuals. Sanctions rules apply when the case is created. Sanctions related to these specific issues will need to be suspended once the case is created.
- Applicants who fail to cooperate with child support or meet the work requirements who do not have existing sanctions in NC FAST, will not be sanctioned until the COVID-19 public health emergency period ends.
- NC FAST will produce and post a report in FAST Help that identifies active and pending closure cash assistance cases that currently have a Work First cash

assistance sanction beginning with the month of March and each month there after until the COVID-19 public health emergency period ends.

- A communication will be sent to counties from NC FAST when the report is available in FAST Help.
- Once the report is posted in FAST Help, counties must review and end date the sanctions on the active Work First cash assistance cases.
- After the COVID-19 public health emergency declaration is lifted, NC FAST will reinstate the remaining sanction period for cases that had sanctions suspended during this period.

### III. IMPLEMENTATION PROCEDURES

NC FAST will reinstate all sanctions suspended during the COVID-19 public health emergency period that have months remaining. Sanctions not imposed for new applications must be imposed and entered into NC FAST by county staff; manual records of all Work First cash assistance cases with sanctions pending is required to ensure that Work First cash assistance cases are in compliance with Work First policy when the COVID-19 public health emergency ends.

## IV. EFFECTIVE DATE

This policy is effective upon receipt. All provisions implemented will be allowed until the COVID-19 public health emergency declaration by the Secretary of Health and Human Services is lifted.
